\*Education Law §6305 provides: "The chief fiscal officer of each county as defined in Section 2.00 of the local finance law, shall upon application and submission to him satisfactory evidence, issue to any person desiring to enroll in a community college as a non-resident student, a certificate of residence showing that said person is a resident of said county. Such person shall, upon his registration for each college year, file with the college such a certificate of residence issued not earlier than two months prior thereto, and such certificate of residence shall be valid for a period of one year from the date of issuance." Education Law, §6301 Paragraph 4 defines: "Resident", a person who has resided in the state for a period of at least one year and in the county, city, town intermediate school district or school district, as the case may be, for a period of at least six months, both immediately preceding the date of such person's registration in a community college or for the purposes of §6305 of this chapter, his application for certificate of residence.
